Workshop on Air Transport and Regional Development to be held in Poznań University of Economics and Business on 6th and 7th of September 2018 is titled **The impact on economy of hub airports operation and infrastructure development**. The topic is related with the new central airport for Poland to be built in the next five years and closure of Warsaw Airport, which is close to its capacity and struggles with negative environmental effects. The new central airport is intended to become a hub for Central and Eastern Europe. About COST ATARD
